Heather Wright presented two national brands that are interested in coming to the new development on Avalon. This would be a cost of approximately \$8.9 million.



COUNCIL MEMBER – PLACE TWO





The invocation was given by Chad Holden. President Ken Sockwell led in the pledge of allegiance.


