

**MINUTES FROM A REGULAR MEETING OF THE
COUNCIL OF MUSCLE SHOALS, ALABAMA, HELD
March 5, 2007**

The Council of Muscle Shoals, Alabama met at the Muscle Shoals City Hall in said City at 6:30 p.m. on the 5th day of March 2007 being the regularly scheduled time and approved place for said meeting. The meeting was called to order by David Bradford, Mayor of the City. The invocation was given by Ron Ethridge, Pastor of Woodward Avenue Baptist Church. On roll call the following members were found to be present or absent, as indicated:

Richard Williams, City Clerk of the City, was present and kept the minutes of the meeting.

David Bradford, Mayor of the City, presided at the meeting and declared that a quorum was present and that the meeting was convened and opened for the purposes of transaction of business.

Be it ordained by the Council of the City of Muscle Shoals, Alabama, that the Zoning Ordinance and the Zoning Map of the City of Muscle Shoals, are hereby amended as follows:

That the following described areas are hereby eliminated from the B-1 District in which it is now situated, and is hereby incorporated in and made a part of the B-2 District, to wit:

Lots 1 thru 8 in Belva Subdivision, lots are located at the southeast corner of the intersection of Marymack Avenue & River Road. This tract of property is 200' by 120'. Colbert County Tax Parcel # 08-04-19-4-001-002.000.

Lots are located at the northeast corner of the intersection of John R. Street and Highland Avenue. This tract is 120' by 125'. Colbert County Tax Parcel # 13-01-02-2-003-031.000 thru 032.000.
