

ORDINANCE NO.1541 - 21
AN ORDINANCE TO AMEND THE ZONING ORDINANCE AND
ZONING MAP OF THE CITY OF MUSCLE SHOALS, ALABAMA

Be it ordained by the Council of the City of Muscle Shoals, Alabama, that the Zoning Ordinance and the Zoning Map of the City of Muscle Shoals, are hereby amended as follows:

That the following described area which is currently zoned B-2 and is hereby incorporated in and made a part of the M-1 District, to wit:

Begin at a point being the southwest corner of the right-of-ways at the intersection of Sixth Street and Industrial Drive, run south along the western right-of-way of Industrial Drive for a distance of 246.67 feet, being the point of beginning. Thence proceed south along Industrial Drive right-of-way for a distance of 623.33 feet, thence run due west for a distance of 499.03 feet, thence run due north for a distance of 623.33 feet, thence run east for a distance of 499.03 feet.



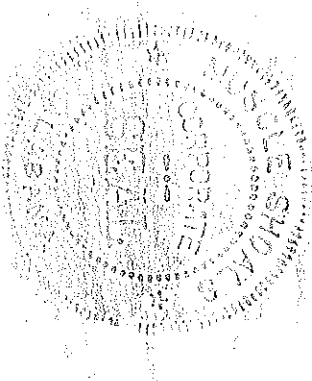



