

Councilmember Hall moved for unanimous consent of the Council to suspend the rules of procedure to allow for the immediate consideration of the following Ordinance:

ORDINANCE NO. 1518 - 20

AN ORDINANCE APPROVING CERTAIN AGREEMENTS BETWEEN CITY OF MUSCLE SHOALS, ALABAMA AND THE SOLID WASTE DISPOSAL AUTHORITY OF THE CITIES OF MUSCLE SHOALS, SHEFFIELD, AND TUSCUMBIA, ALABAMA

WHEREAS, the Solid Waste Disposal Authority of the Cities of Muscle Shoals, Sheffield, and Tuscumbia, Alabama (the "Authority") has proposed to issue certain revenue bonds (the "Bonds") in order to finance the acquisition and improvement of the Cherokee Industrial Landfill (the "Project") located in the County;

WHEREAS, the City will have no financial obligation with respect to such Bonds or any obligation of any kind with respect to the Project;

WHEREAS, the City expects to be a customer of the Authority and to utilize the Project for public use;

WHEREAS, the Authority has presented to the City a customer and flow control agreement and an agreement with respect to the payment the City of a share of certain royalty payments from CWI Cherokee LF LLC to the Authority.

BE IT ORDAINED by the CITY COUNCIL (the "Council") of THE CITY OF MUSCLE SHOALS, ALABAMA (the "City"), as follows:

1. The Project proposed to be undertaken by the Authority is in the best public and financial interest of the City.

2. The Agreement Between the Authority and the City For Municipal Solid Waste and Construction and Demolition Waste, Inert Waste, and Recyclable Materials is hereby ratified, adopted and approved, and the Mayor and the City Clerk are hereby authorized and directed to execute, attest, seal, and deliver the same to the Authority.

3. The Intergovernmental Agreement between the City and the Authority with respect to the royalty payments is hereby ratified, adopted and approved, and the Mayor and the City Clerk are hereby authorized and directed to execute, attest, seal, and deliver the same to the Authority.

4. The Mayor is authorized to execute and deliver on behalf of the City such other documents as may be reasonably requested by the Authority in connection herewith.

5. This resolution shall take effect immediately.

The motion for unanimous consent was seconded by Councilmember Sockwell and upon the question, the vote thereon was as follows:


The Mayor thereupon declared said ordinance passed and adopted as introduced.




