

EXCERPTS FROM MINUTES OF A REGULAR MEETING OF THE  
COUNCIL OF MUSCLE SHOALS, ALABAMA HELD  
October 5, 2020

---

The Council of Muscle Shoals, Alabama met at the City Hall in said City at 6:00 o'clock p.m. on the 5<sup>th</sup> day of October, 2020, being the regularly scheduled time and place for said meeting. The meeting was called to order by Allen Noles, President of the City Council. On roll call the following were found to be present or absent, as indicated:

ABSENT: NONE

Richard L. Williams, City Clerk of the City, was present and kept the minutes of the meeting.

Allen Noles, President of the City Council, presided at the meeting and declared that a quorum was present and that the meeting was convened and opened for the purposes of transaction of business.

President Noles announced that the next order of business was consideration of the proposed Ordinance to amend the Zoning Ordinance and Zoning Map of the City.

The following Ordinance was before the Council, this being the time and place as previously set by the Council for consideration of the proposed Ordinance:

**ORDINANCE NO. 1526 - 20**  
**AN ORDINANCE TO AMEND THE ZONING ORDINANCE AND**  
**ZONING MAP OF THE CITY OF MUSCLE SHOALS, ALABAMA**

Be it ordained by the Council of the City of Muscle Shoals, Alabama, that the Zoning Ordinance and the Zoning Map of the City of Muscle Shoals, are hereby amended as follows:

That the following described area which are currently B-2 and is hereby incorporated in and made a part of the R-2 District, to wit:

Lots 3905 thru 3917 & East 120' of Blk A Tract 1, Lots 3928 thru 3930 & 305' x 1335' in part of S ½ of NW 1/4 of NW 1/4 of Highland Park Subdivision #10

President Noles noted that proper notice had been given of the hearing on the proposed Ordinance. It was further noted that October 5, 2020 was the date set for such hearing. Hearing was had and opportunity given for all persons in favor or opposed to said proposed Ordinance. After consideration of same, President Noles announced that final adoption of the proposed Ordinance as advertised was now before the Council and, upon said motion being put to a roll call vote, a vote was had and the vote was recorded as follows:

Council Member Sockwell, Council Member Noles


NAYS: None.

President Noles announced that the vote was unanimous in favor of the Ordinance and the Ordinance was adopted.


There being no further business to come before the meeting, upon motion duly made, seconded and unanimously carried, the meeting was adjourned.


