Be it ordained by the Council of the City of Muscle Shoals, Alabama, that the Zoning Ordinance and the Zoning Map of the City of Muscle Shoals, are hereby amended as follows:

That the following described area which are currently R-3 and is hereby incorporated in and made a part of the M-1 District, to wit:

Lots 274 thru 281, Riverside Park Subdivision

President Noles noted that proper notice had been given of the hearing on the proposed Ordinance. It was further noted that October 5, 2020 was the date set for such hearing. Hearing was had and opportunity given for all persons in favor or opposed to said proposed Ordinance.
