MINUTES FROM A REGULAR MEETING OF THE COUNCIL OF MUSCLE SHOALS, ALABAMA HELD October 5, 2020

The Council of Muscle Shoals, Alabama met at the City Hall in said City at 6:00 o'clock p.m. on the 5th day of October 2020, being the regularly scheduled time and place for said meetings. The meeting was called to order by Allen Noles, President of the Council. On roll call the following were found to be present or absent, as indicated:

Richard L. Williams, City Clerk of the City, was present and kept the minutes of the meeting.

Allen Noles, President of the Council, presided at the meeting and declared that a quorum was present and that the meeting was convened and opened for the purposes of transaction of business.

Council Member McMinn introduced the following Ordinance in writing which was read at length and presented to the meeting.

AN ORDINANCE PERTAINING TO THE PROHIBITION OF PLACING OR CAUSING TO BE PLACED GRASS CLIPPINGS IN PUBLIC STREETS, GUTTERS OR STORM DRAINS WITHIN THE CITY LIMITS OF THE CITY OF MUSCLE SHOALS AND ITS POLICE JURISDICTION

BE IT ORDAINED by the City Council of the City of Muscle Shoals, Alabama that Chapter 94 of the Code of Ordinances, City of Muscle Shoals, Alabama, as amended, is hereby amended to include the following as addition to Section 94-16 (a) and 94-16 (b) (1) (a) and 94-16 (b) (2) (a):

Sec. 94-16. – Clearing of trash and debris and cutting of weeds; removal of junk and nonconforming vehicles.

(a) Definitions

Yard Trash: Grass clippings and cuttings resulting from normal maintenance of grounds and lawns.

BE IT FURTHER ORDAINED by the City Council of the City of Muscle Shoals, Alabama that Chapter 94 of the <u>Code of Ordinances</u>, <u>City of Muscle Shoals</u>, <u>Alabama</u>, as amended, is hereby amended to include the following as addition to Section 94-16 (b) (1) (a) and 94-16 (b) (2) (a):

(b) (1) (a) The placing, or causing to be placed, of any yard trash as defined herein in public streets, gutters or over storm drains is prohibited.

BE IT FURTHER ORDAINED by the City Council of the City of Muscle Shoals, Alabama that Chapter 94 of the Code of Ordinances, City of Muscle Shoals, Alabama, as amended, is hereby amended to include the following as addition to Section 94-16 (b) (2) (a):

(b) (2) (a) The placing, or causing to be placed, of any yard trash as defined herein in public streets, gutters or over storm drains is prohibited

BE IT FURTHER ORDAINED that this Ordinance, and its provisions, shall become effective upon publication or posting pursuant to law or as otherwise provided for by law.

Council Member Mc / Vinn moved that unanimous consent be given for the
immediate consideration of and adoption of said Ordinance, which motion was seconded by
Council Member Hall, and, upon said motion being put to a vote, a roll call
was had and the vote was recorded as follows:

The President announced the vote and declared that the motion for unanimous consent for
immediate consideration of and adoption of the Ordinance had been carried unanimously.

adopted, which motion was seconded by Council Member, and, upon
said motion being put to a vote, a roll call on final adoption was had and the vote was recorded as
follows:
