
Brittney Walker gave an update regarding step raises. She discussed that the committee meetings were beneficial, and the next scheduled meeting was Wednesday, April 3rd.


COUNCIL MEMBER – PLACE ONE

COUNCIL MEMBER – PLACE THREE




COUNCIL MEMBER – PLACE FOUR

**MINUTES FROM A REGULAR MEETING

April 1, 2024**

The City Council of Muscle Shoals, Alabama met at the Muscle Shoals City Hall auditorium in said City at 5:30 p.m. on the 1st day of April 2024 being the scheduled place for said meeting once the previously held work session ended. The meeting was called to order by Ken Sockwell, Council President. On roll call the following members were found to be present or absent, as indicated:



COUNCIL MEMBER – PLACE ONE




COUNCIL MEMBER – PLACE TWO
