

**MINUTES FROM A WORK SESSION OF THE
COUNCIL OF MUSCLE SHOALS, ALABAMA, HELD
APRIL 4, 2022**

The City Council of Muscle Shoals, Alabama met at the Muscle Shoals City Hall auditorium in said City at 5:30 p.m. on the 4th day of April, 2022. The following members were found to be present or absent, as indicated:

Ken Sockwell, Council President, presided at the meeting. Mayor Mike Lockhart was also present. Elaine Coan, City Clerk, was present and kept the minutes of the meeting.

Chris Franconi, a resident of Dalton Estates spoke with the council to inquire about putting a gate at the entrance of the subdivision. He told about cars speeding through the subdivision and that some of his neighbors had cars broken into at night. He would give the necessary persons a generic code for entrance through the gate. Also, he said that 70% of other residents were in agreement that the gate is needed. City Attorney Marcel Black explained to Mr. Franconi that according to the City Code that all subdivisions must have public access. The Council told him that they would have Mr. Black do further research.

Penny Terry, who resides at 701 Edison Avenue spoke with the council about garbage being dumped in the ditch on Eason Avenue across the street from her home. Butch Fleming, Ryan Kennedy, and Kevin Williams had checked into this ditch, and Mr. Fleming had spoken with the owner of the surrounding apartments. He asked the manager about her purchasing a dumpster for the apartment tenants, and for use when cleaning out apartments. He told the council that other apartment complexes have dumpsters, and provided pictures of them. Ms. Terry was encouraged to attempt to get the license plate numbers to report to the police department. The council asked Mr. Black to research having an ordinance in place requiring apartment complexes to have a dumpster.

The council discussed agenda items.

There being no further business the meeting was adjourned at 6:15 p.m.



**MINUTES FROM A REGULAR MEETING OF THE
COUNCIL OF MUSCLE SHOALS, ALABAMA, HELD
April 4, 2022**

The City Council of Muscle Shoals, Alabama met at the Muscle Shoals City Hall auditorium in said City at 6:15 p.m. on the 4th day of April, 2022 being the scheduled time and place for said meeting. The meeting was called to order by Ken Sockwell, Council President. On roll call the following members were found to be present or absent, as indicated:

ABSENT: NONE

Ken Sockwell, Council President, presided at the meeting and declared that a quorum was present and that the meeting was convened and opened for the purposes of transaction of business. Mayor Mike Lockhart was also present. Elaine Coan, City Clerk, was present and kept the minutes of the meeting.

The invocation was given by Chad Holden. Council President Ken Sockwell led in the pledge of allegiance.

Upon motion duly made by Council Member Thompson and seconded by Council Member Hall and unanimously adopted, the Council waived the reading of the minutes of the previously held regular meeting and work session of March 28th, 2022 and approved the minutes as written.

Mayor Lockhart expressed his appreciation to the police and fire departments for the good job they did while responding to the accident on Woodward Avenue involving multiple cars. Also, he thanked the police department on the response of the situation at McBride Middle School.

Chad Holden, the school superintendent spoke about the situation, and thanked the police department, the School Resource Officer, and Chief Reck for the quick response to the school. He expressed appreciation for the administration for following protocol.

Council Member Clark introduced the following resolution and moved for its adoption:

RESOLUTION NUMBER 3198-22

WHEREAS, the City Council of the City of Muscle Shoals, Alabama approved the purchase of refuse containers for refuse collections; and

WHEREAS, the Procurement Agent advised that the amount of said purchase must comply with the Alabama Competitive Bid Law and further that a purchasing cooperative contract eliminating the need for further formal, sealed bidding process has been approved by the State of Alabama and is valid for such purchase; and

WHEREAS, the Procurement Agent further advised that the purchase price for 486 refuse containers is \$35,380.58 to be purchased from Schaefer Systems International, Inc., and further that Schaefer Systems International, Inc. is the awarded contractual vendor for said item with HGACBuy, a State of Alabama approved purchasing cooperative; now

THEREFORE, BE IT RESOLVED by the City Council of the City of Muscle Shoals that Schaefer Systems International, Inc. the contractual vendor of HGACBuy is now hereby awarded the purchase of 486 refuse containers for the total purchase price of \$35,380.58.

Council Member Moore seconded the motion and upon motion being put to a vote, all voted "AYE" and "NAYS" were none.

President Sockwell announced that the resolution had been approved.



There being no further business to come before the meeting, upon the motion duly made and seconded the meeting was adjourned.



COUNCIL MEMBER - PLACE ONE




COUNCIL MEMBER - PLACE TWO



COUNCIL MEMBER - PLACE THREE




COUNCIL MEMBER - PLACE FOUR


