WHEREAS, that the Procurement Agent advised that the purchase must comply with the Alabama Competitive Bid Law requirements, and that a cooperative contract approved by the State of Alabama is valid for such purchase; and

WHEREAS, the Procurement Agent further advised that the total purchase price for Rev 4 Firefighting Equipment and Rescue Tools is \$49,065.00 to be purchased from Municipal Emergency Services and further Municipal Emergency Services is the awarded contractual vendor for said item with Sourcewell, a State of Alabama approved governmental purchasing cooperative; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Muscle Shoals that Municipal Emergency Services is awarded the purchase of the approved Rev 4 Firefighting Equipment and Rescue Tools for the total purchase price of \$49,065.00.
