The City Council of Muscle Shoals, Alabama met at the Muscle Shoals City Hall auditorium in said City at 6:00 p.m. on the 18th day of July, 2022 being the scheduled time and place for said meeting. The meeting was called to order by Ken Sockwell, Council President. On roll call the following members were found to be present or absent, as indicated:

Ken Sockwell, Council President, presided at the meeting and declared that a quorum was present and that the meeting was convened and opened for the purposes of transaction of business. Mayor Mike Lockhart was also present. Financial Officer, Brittney Walker was present and kept the minutes of the meeting.

ORDINANCE NO.____ AN ORDINANCE TO AMEND THE ZONING ORDINANCE AND ZONING MAP OF THE CITY OF MUSCLE SHOALS, ALABAMA

Be it ordained by the Council of the City of Muscle Shoals, that the Zoning Ordinance and the Zoning Map of the City of Muscle Shoals are hereby amended as follows:

Proposed Change – Description:

Amending the ordinance to rezone property located on West Eason Avenue, one parcel west of Woodward Avenue, Parcel 07-07-35-2-012-007.000 Lots 278 thru 280 Highland Park #1 DB 2008 PG 171 and DB 2008 PG 8725 (Colbert County Parcel Viewer)

Proposed Change – Description:

Amending the ordinance to rezone property adjacent to Second Street from Union Avenue to the Muscle Shoals City Limits from M-1 to B-2 and R-3.

At same time and place, all persons who desire to do so shall have an opportunity of being heard in opposition to or in favor of the adoption of said Ordinance.

A RESOLUTION APPOINTING A DIRECTOR TO GREATER SHOALS BROADBAND COOPERATIVE DISTRICT FROM THE CITY OF MUSCLE SHOALS, ALABAMA

WHEREAS, the City Council of Muscle Shoals, Alabama as a member of the Greater Shoals Broadband Cooperative District finds it mete and proper to appoint a Director to said cooperative district pursuant to Certificate of Incorporation filed on June 1, 2022 and recorded at RLPY 2022 at Page 31464 in the Probate office of Lauderdale County, Alabama;

NOW THEREFORE BE IT RESOLVED, by the Council of the City of Muscle Shoals, Alabama that James Nipper is hereby appointed to serve as a Director of the Greater Shoals Broadband Cooperative District

ADOPTED and APPROVED this the 18th day of July 2022.

President Sockwell announced that the resolution had been approved.

President Sockwell announced that the next item of business was consideration of a resolution to approve a temporary moratorium. Council Member Moore introduced the following resolution and moved for its adoption:

STATE OF ALABAMA COLBERT COUNTY

RESOLUTION NO. 3217-22

WHEREAS, the Council of the City of Muscle Shoals has entered into an agreement with Goodwyn, Mills and Cawood (GMC) to prepare a long-range, comprehensive development plan addressing future growth in the City of Muscle Shoals, Alabama; and

WHEREAS, the plan will address, among other things, community and urban design standards for commercial districts, the safe and convenient access and land use along transportation corridors, and the arrangement of land uses in relation to transportation and other infrastructure in the City of Muscle Shoals, Alabama; and

WHEREAS, the completed plan will aid the Council in reviewing, amending, and enacting laws regulating the location, character, and density of land uses in the City of Muscle Shoals so as to increase the number and quality of employment opportunities in a way that maximizes the City's investment in existing and future municipal infrastructure and furthers the City's long-range planning goals; and

WHEREAS, the traffic generation, land use character, and low employment density in relation to land area often accompanying commercial developments providing automated or self-service goods and services, i.e. coin-operated laundries; self-service movie and video rental

kiosks; self-service ice machines; and self-service automobile cleaning and detail operations threatens future efficient commercial development within the City of Muscle Shoals and undermines the development of the comprehensive long-range plan; and

WHEREAS, the Council believes that a temporary moratorium on the issuance of building permits and/or licenses to the above-described land uses best protects the public interest and welfare of the citizens of Muscle Shoals by preventing a "rush" to development prior to the City's review of the comprehensive long-range plan, inefficient and ill-conceived growth, and immediate construction that might be inconsistent with the provisions of the comprehensive long-range plan.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Muscle Shoals, Alabama a temporary moratorium is hereby imposed upon the issuance of building permits and/or licenses to coin-operated laundries; self-service movie and video rental kiosks; self-service ice vending machines; and self-service automobile cleaning and detail facilities.

BE IT FURTHER RESOLVED, that the temporary moratorium imposed hereby shall expire at midnight on the 180th day following the adoption of this Resolution.

BE IT FURTHER RESOLVED, that the temporary moratorium imposed hereby shall in no way affect the validity of any business license or building permit issued by the City of Muscle Shoals, Alabama prior to the adoption of this Resolution.

BE IT FURTHER RESOLVED, that the temporary moratorium imposed hereby shall not be construed to prevent the renewal of any current business license issued by the City of Muscle Shoals, Alabama, provided that such renewal is sought in compliance with existing laws, rules, and regulations governing the renewal of business licenses.

Council Member Clark seconded the motion and upon motion being put to a vote, all voted "AYE" and "NAYS" were none. President Sockwell announced that the resolution had been approved.

There being no further business to come before the meeting, upon the motion duly made and seconded the meeting was adjourned.
