



COUNCIL MEMBER – PLACE ONE




COUNCIL MEMBER – PLACE TWO



COUNCIL MEMBER – PLACE THREE




COUNCIL MEMBER – PLACE FOUR

The City Council of Muscle Shoals, Alabama met at the Muscle Shoals City Hall auditorium in said City at 6:00 p.m. on the 3<sup>rd</sup> day of June 2024 being the scheduled place for said meeting once the previously held work session ended. The meeting was called to order by Ken Sockwell, Council President. On roll call the following members were found to be present or absent, as indicated:


COUNCIL MEMBER - PLACE ONE




COUNCIL MEMBER - PLACE TWO



COUNCIL MEMBER - PLACE THREE




COUNCIL MEMBER - PLACE FOUR
